WTLS CAN HELP

Before a disaster hits, keep a list of your important documents. Store important documents in a safe deposit box or keep copies at a place other than your home that you trust and know is safe. Scan and upload them to your email account or take photos of them that are backed up to the web. Wherever you choose to keep backup copies of your documents, be sure that it is safe and, if online, password protected.

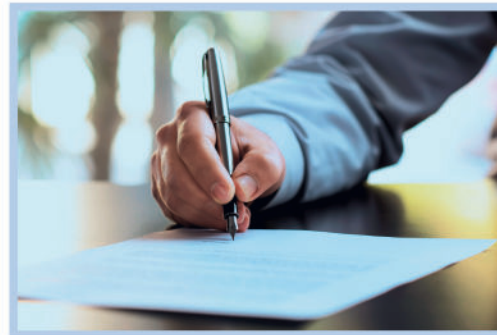
These documents include:

- Wills, trusts, powers of attorneys
- Birth/marriage certificates
- Identification
- Social security card
- Passport
- Naturalization/residency papers
- Titles/Deeds

Replacing your important documents that were lost or destroyed in a flood, fire, or other disaster can be overwhelming. West Tennessee Legal Services can help you get the process started and assist you in replacing your lost documents.

Get help with things like:

- Birth/Death Certificate
- Car Title
- Credit Cards
- Driver's License
- EBT & SNAP
- Green Card
- Home/Title/Deed
- Marriage/Divorce Certificate
- Medicare Card
- Passports
- Social Security Card



Disasters can lead to other legal issues. For example, tenants may face eviction or rental issues due to damage to the home they are renting.
