BE PREPARED

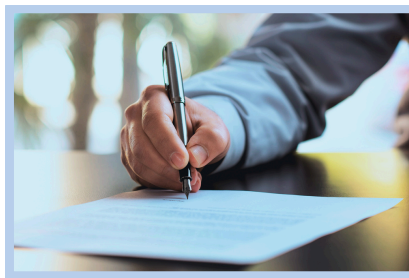
During a disaster your main concern will be yours and your family's safety. However, you will need records and information to start a recovery. Take the time now to prepare. Before a disaster, keep a list of your important documents.

- Store **paper** copies in a fireproof and waterproof safe, safety deposit box or keep copies with a trusted friend or family.
- Store **electronic** copies on a flash drive in a safe place or scan and upload them to your email account or take photos of them that are backed up and password protected.
- Where are your valuable belongings? Are they in a safe place or somewhere you can get them if you need to evacuate?
